Governing Law: This MOU shall be governed by and construed in accordance with the laws. Any dispute arising under this MOU shall be resolved through mediation, and if mediation is unsuccessful, through arbitration in accordance with the rules of arbitration law.

Entire Agreement: This MOU constitutes the entire agreement between the parties and supersedes all prior understandings, agreements, or representations, whether written or oral, relating to the subject matter of this MOU.
